The reasons for my opposition are:

- *The proposed rezoning will result in a high number of properties being built along the ridgeline of the Silverstream and Pinehaven Hills. I believe that the ridgeline should be protected in its natural state at all times in order to preserve the significant environmental beauty of the suburbs and natural ecological characteristics of this area.*
- *The proposed rezoning if approved will, in my opinion, cause very serious traffic congestion and high risk of flooding of existing properties, in both the Pinehaven and Silverstream areas.*

- *During my period of employment with Hutt County Council, I was required to investigate a number of cases of drainage and pollution of water courses in Pinehaven, Silverstream and Whiteman's Valley. 



Dawson further submission on submission 162, PC50

I am writing to express my concerns with the proposed re-zoning of the Silverstream and Pinehaven Hills, sometimes known as the Southern Growth Area (SGA).

I am a resident of Kiln Street, Silverstream and have not made a previous submission on the proposal because at no time was I made aware of the plan change. I will be directly affected by any adverse traffic, stormwater and amenity effects of potential development as a result of the zone change.

In particular I am concerned about the lack of information provided by the Guildford Timber Company (GTC - Submitter 162) around long-standing issues in our community as well as concerns around the process of the plan change. These include stormwater run-off and traffic management around the Pinehaven and Silverstream.

My key concerns are outlined below:

Stormwater

Stormwater overflow is a long-standing issue in the Pinehaven and Silverstream, but particularly in Pinehaven. The number of overland flow paths and streams in the area mean that at times of heavy rain there is excess water running through residential areas. I believe many other residents will submit in further detail on this. While I do not expect that a plan change submission, like that of submission 162, would provide a detailed plan to address this, I firmly believe that it would be inappropriate to change to a residential zoning without a clear path forward to address this. Particularly where future residential development will only exacerbate the issue.

It is those who live in Pinehaven and Silverstream who will bear the ill-effects of poor stormwater management.

Traffic

The current roundabout at Kiln Street and Field Street is already significantly busier than the intersection type allows. Increasing traffic flows down Kiln Street from any future development will only make it near-impossible for residents to navigate their way in and out of the suburb. Again, I do not expect a great level of detail from submitter 162 for the plan change itself, but there do need to be checks and balances in the zone rules to ensure that the roading infrastructure is appropriately upgraded as needed to keep up with residential development. This could take the form of a specific distinction rule within the zone/precinct to ensure that developers contribute to the infrastructure upgrades necessary.

Social infrastructure

The current schools, early childcare, medical practices and shops in the area will not be adequate to support the increase in density that future development enabled by PC50. I believe that the zone should include specific rules that require an allowance of social infrastructure per number of residential units in any future development.

Alternative areas

I question the need for so much additional housing into greenfields areas, when the focus should be on sustainable development of our brownfields areas in the first instance.

This has significantly better outcomes for waste, climate, access to public transport and amenities, and requires less investment into infrastructure and services. I also question what growth projects the UHCC are working to that requires them to provide so much additional land for housing. Has this work been undertaken, and has it been provided to the public?

I submit that the Council and developers should also be focussed on other, more appropriate areas of future development, such as the Whitemans Valley area. In the current fiscal climate it does not make sense to develop into an area like the SGA which requires such a significant upgrade to all infrastructure, including stormwater and roading. I believe it would be more appropriate to focus on the low hanging fruit that we have within our area.

Future resource consenting

I note that the Guildford Timber Company submitted in support of the Fast Track Approvals Bill currently at Select Committee. If an SGA development is consented through that pathway, as the Bill is currently written this does not allow for any further public participation in the decision-making. Concerned residents will not have an opportunity to see the detailed application documentation and assessment of environmental effect of any proposal.

This means that this proposed plan change may be the only opportunity that residents have to understand what will happen in our suburb and what the adverse effects may be. Upper Hutt City Council needs to consider this when making their decision on the plan change with the scant information provided.

Process concerns

I am concerned that the Upper Hutt City Council have pre-determined the outcome of this proposed plan change. Specifically the UHCC letter to GTC stating they support the plan change and intend to provide the necessary approval.

I find this inappropriate as the process is still ongoing and submissions are still being heard. This conduct does not give local residents confidence that this will be a fair process and a lot of trust has been lost as a result.

Summary

Overall I do not oppose future development in the SGA and therefore this plan change, but the process thus far of plan change 50, Council letter of support, the submissions process and potential for fast tracked consenting leaves me deeply concerned.

I believe that there need to be appropriate rules applied to this zone to ensure that infrastructure (roads, stormwater, schools, medical centres etc) is upgraded to support any future growth in the area and provide necessary resilience.




