Details of submission The specific provisions of the proposed Plan Change that my submission relates to are as follows: GRUZ-S14 proposes that each residential unit that is not connected to Council's reticulated water supply must have (..) b) a domestic fire sprinkler systems in accordance with NZS 4541:2013 that is connected to a firefighting water supply in accordance with the New Zealand Fire Service Firefighting Water Supplies Code of Practice SNZ PAS 4509:2008. My submission is that: NZS 4541 is more applicable commercial buildings. It might be more appropriate and cost effective to install sprinklers in single family dwellings to NZS 4517:2010 Fire sprinkler systems for houses. NZS 4541:2013 is superseded, the newest edition (which is also, as of last week, currently cited in the acceptable solutions for fire C/AS2 and C/VM2) is NZS 4541:2020 Unless the intent is to have a firefighting water supply in addition to a sprinkler system, either sprinkler standard contains requirements for the water supply for that system. The water supply is determined by calculations based on the system's design. Reference to SNZ PAS 4509:2008 may conflict with the results of those calculations and make it difficult to install a sprinkler compliant with the appropriate standard. Consider also whether other non-residential buildings not connected to the reticulated water supply will also require sprinklers and/or water supply for firefighting which currently do not need these?
